### In the News

- The President proposed increasing **abstinence-only-until-marriage programs** to \$204 million. This includes increasing the **Community-Based Abstinence Education (CBAE)** account by \$27 million to \$141 million, which includes a continuation of \$4.5 million for the **national evaluation** of abstinence-only programs and up to \$10 million, which will be available to fund a national abstinence-only awareness campaign. As in past years, the President’s request includes flat funding of \$50 million for **Title V** (authorized under welfare reform) and \$13 million within the **Adolescent Family Life Act (AFLA)** that is explicitly tied to the same definition of “abstinence education” as the other two programs. The Budget also expresses support for increasing funding for abstinence-only programs to \$270 million by 2009, and continuing providing \$4.5 million for abstinence program evaluations each year.
